FOUNDATION FOR LOUISIANA GRANTS \$843,000 TO 22 NONPROFIT ORGANIZATIONS THROUGHOUT STATE

New funding will support small businesses, affordable housing and strategies to fight poverty and blight

Baton Rouge, La. – Foundation for Louisiana is pleased to announce grant awards totaling \$843,000 to 22 nonprofit organizations serving dozens of communities throughout the state. Foundation for Louisiana’s first grant cycle builds upon the work of its predecessor, the Louisiana Disaster Recovery Foundation, by continuing to strengthen Louisiana’s nonprofit sector and supporting citizen engagement, the creation of affordable housing and economic opportunity in low-wealth communities, and small businesses.

Samuel Sanders, Executive Director of Baton Rouge’s Mid City Redevelopment Alliance, has said, “Mid City Redevelopment Alliance is so proud to be included in the inaugural round of funding from the Foundation for Louisiana. We are excited by the support we have received to assist us in strategically planning our next 20 years of celebrating the people, places and progress of the Mid City region of Baton Rouge.”

Aimee Smallwood, CEO of the Louisiana Cultural Economy Foundation (LCEF), responded to the news that her organization was awarded a Foundation for Louisiana grant by saying, “The Louisiana Cultural Economy Foundation is grateful to Foundation for Louisiana for funding of Economic Opportunity Fund/ Regional Development Agency Partnership project, which will provide assistance to self-employed individuals, nonprofits and businesses. We believe that the goals of this project parallels those of the Foundation for Louisiana in trying to remove institutional and structural barriers to economic well-being, increase access to opportunity, cultivate local leadership.” Foundation for Louisiana’s grant to LCEF will serve parishes and communities throughout the state.

The 22 grants support projects in 3 program areas: small business, housing, and policy & advocacy.

Small business grants include:

\$50,000 to Shreveport Regional Arts Council to support development of the Northwest Louisiana Arts Resource Center that will help arts-based businesses to open and achieve sustainability.

\$40,000.00 to Habitat for Humanity of Ouachita to open a Habitat ReStore in Monroe, La. The store will be located on the I-10 corridor serving Ouachita, Monroe, Ruston and

Tallulah, providing affordable building materials to homeowners, revenue to support construction of Habitat homes, and reducing landfill use.

\$50,000 to LSU Foundation to support the E.J. Ourso College of Business's Supplier Diversity and Inclusion Initiative, which will provide small, women- and minority-owned businesses in 37 rural parishes with resources and information that will enable them to compete for state contracts and increase economic resiliency in rural communities.

Housing grants include:

\$70,000 to Rays of Sonshine to provide permanent supportive housing for homeless moms and children in Monroe's Adkins Quarters neighborhood. This grant is complemented by a \$7500.00 advocacy grant the Foundation has made to Community of Hope in Monroe to support community engagement around blight and redevelopment in the Adkins Quarters neighborhood.

\$75,000 to Urban Restoration Enhancement Corporation to support the Urban Gardens Project, providing affordable housing for low- to moderate-income families in North Baton Rouge.

\$25,000 to the Phoenix of New Orleans to help displaced families to complete repairs on their damaged homes, thus reducing blight and getting families back into safe homes.

Policy grants include:

\$50,000 to Loyola University's Workplace Justice Project to address employer wage theft impacting immigrant and low-wage workers by drafting and promoting a state wage lien law.

\$35,000 to Center for Community Progress to develop policy and legislative initiatives to prevent property blight and abandonment, reform land acquisition practices and address land disposition throughout the state.

"These grants exemplify Foundation for Louisiana's mission to build resilience in the state's most vulnerable communities. They also honor the legacy of the Louisiana Disaster Recovery Foundation and the vision its founders had for addressing the long-term challenges of poverty, disinvestment and inequity in our state," said Flozell Daniels, Jr., Foundation for Louisiana President and CEO.

Over the next five years, Foundation for Louisiana seeks to increase the number of affordable housing units developed within Louisiana, increase the number of small and disadvantaged businesses obtaining public contracts, and increase the buying and saving power of the state's poorest citizens. The Foundation expects to make significant progress towards these goals with this first round of grant awards.
